This Privacy Notice describes how **Roofers' Advantage® Products, Inc.** (“Company,” “we,” “us,” or “our”) collects, processes, and discloses your personal information (including sensitive personal information).

This Privacy Notice applies to all instances in which you provide, or we otherwise collect, personal information, including, but not limited to, through or in connection with (a) our products and services, such as by registering for any of our product warranties or guarantees; (b) our emails and digital platforms, such as social media platforms, portals, websites, and applications (collectively, “our digital platforms”) that link to this Privacy Notice; and (c) our electronic communications.

Please read this Privacy Notice carefully to understand how we handle your information. We will notify you of any material changes by posting the updated policy on this page.

Who This Notice Covers

This Privacy Notice covers consumers and individuals acting in a personal context. Except where required by law, this Notice does not apply to personal information we collect from our own employees or job applicants. It also does not apply to employees of our business partners or vendors acting in a purely commercial context.

Our Data Collection Practices

The following table summarizes the categories of personal information we collect, the purposes for collection, and whether we “sell” or “share” this information as defined by applicable privacy laws.

Data Collection Details

Identifiers: We collect identifiers such as your name, email, mailing address, and IP address to facilitate service delivery, process warranty registrations, and respond to your inquiries; please note that this data is shared with our marketing partners.

Work Details: We gather work details, including your job title and business contact information, to manage business-to-business relations and track professional certifications, and this information is shared with our marketing partners.

Family Information: Our team collects family information, such as household member names, to personalize our marketing and verify warranty eligibility, though we do not sell or share this specific data.

Financial Information: We collect financial information, such as credit card numbers or bank account details, strictly for the purposes of payment processing and fraud prevention, and we do not sell or share this information.

Commercial Information: We maintain commercial information, including your purchase history and warranty coverage records, to assist with order fulfillment, internal analytics, and the delivery of personalized offers, and this data is shared with our analytics partners.

Photos & Recordings: We collect photos and recordings, such as roof photos and project images, for quality assurance, claims processing, and product research, and we do not sell or share these materials with third parties.

Internet Activity: We track internet activity, such as your browsing history and interactions with our digital platforms, to optimize our website and provide targeted advertising, which involves sharing data for cross-context behavioral advertising.

General Location: We collect general location data, including your city, state, and zip code, to manage service territories and match you with local contractors, and this information is shared with our relevant partners.

What Information We Collect About You

We collect personal information from three primary sources:

1. **Information You Provide Directly:** Information provided when purchasing products, registering warranties, or interacting with our teams.
 2. **Information Collected Automatically:** We and our service providers may use technologies like cookies, pixel tags, and web beacons to collect technical information (IP address, browser type, device identifiers) and interaction data when you visit our platforms.
 3. **Information Collected from Third Parties:** We may obtain information from business partners such as lead providers, roofing contractors, and search engines.

How We Use Your Information

We use your information to:

- Provide services and respond to inquiries.
- Qualify leads and connect you with local contractors.
- Troubleshoot and improve our products, services, and internal operations.
- Conduct online and offline marketing, including personalized advertisements.
- Communicate regarding your accounts, subscriptions, or customer satisfaction.
- Analyze aggregate statistics to understand customer preferences.

Note on SMS: We will only contact you via automated dialing systems or SMS with your prior express written consent. No mobile information will be shared with third parties/affiliates for marketing/promotional purposes.

Who We Share Your Information With

- **Corporate Family:** Other members of our corporate structure for the reasons described above.

- **Vendors & Service Providers:** Third parties that assist with credit card processing, shipping, data management, and communication.
 - **Marketing Partners & Contractors:** Third parties who may use the info for their own purposes, such as joint promotions or training certification verification.
 - **Legal Authorities:** To comply with law, respond to warrants, or protect the rights and safety of the Company and its users.
 - **Business Successors:** As part of a prospective or completed transfer of business assets.

Your Privacy Rights

Depending on your jurisdiction, you may have the right to:
